Running with a Spork is an overview of the Child Nutrition Programs (CNP) administered by the Nevada Department of Education, Office of Child Nutrition and School Health. Data for eligibility, participation, meals, and funding are presented at the State, county, school district, and school levels. In Nevada, school districts are local education agencies (LEAs). The report is divided into four sections: Program Description, Trends, State Overview, and County.

Nevada has experienced significant growth in CNP from 2003 to 2013. All Child Nutrition Programs increased in participation during State Fiscal Year 2012. The current economic conditions in the State have impacted the number of students eligible to participate in multiple free school meals programs. The percent of students eligible to participate in the National School Lunch Program has increased from 52.18% for the 2011-2012 School Year (SY) to 53.58% for the 2012-2013 SY. Breakfast participation increased to 20.65% and lunch participation increased to 48.60% in the 2011-2012 SY.

Nevada was identified by United States Department of Agriculture as one of the top twenty states that exceeds the benchmark for certifying children for free meals. Direct certification allows states and LEAs to use data from other means-tested programs to certify children for free school meals without the need for household applications. The Supplemental Nutrition Assistance Program (SNAP) currently sends eligibility data electronically on a monthly basis to the Nevada Department of Education, which is posted on the System of Accountability Information for Nevada (SAIN) nutrition tab. LEA Food Service Directors and their staff download the data which will be matched to each student on three or more match points (e.g. name, social security number, address) to certify their eligibility. Once certified, a student will receive free meal benefits for the school year.

The Program Description section describes the USDA funded programs: National School Lunch Program (NSLP), Residential Child Care Institutions (RCCI), School Breakfast Program (SBP), Special Milk Program (SMP), Child and Adult Care Food Program (CACFP), Summer Food Service Program (SFSP), Fresh Fruit and Vegetable Program (FFVP), and Wellness.

The Trends section provides an overview of student eligibility, meals, and funding for the past three years.

The State Overview section provides the participation, meals, and funding for the 2011-2012 SY by county for NSLP, SBP, CACFP, SFSP, and FFVP. To complete the section, two maps have been included which indicate the number of child nutrition programs by county. The first map indicates the number of school sites that provide NSLP, FFVP, and SBP including counties that utilize Provision II (all children's meals are free of charge). The second map indicates the number of community sites that provide SMP, CACFP, SFSP, and RCCI.

The National School Lunch Act of 1946, the Child Nutrition Act of 1966 and the Child Nutrition and WIC Reauthorization Act of 2004 allot federal funds to Nevada for nutrition programs which include:

National School Lunch Program (NSLP) provides nutritionally balanced low-cost or free lunches to children each school day. The program is offered in public and non-profit private schools and residential child care institutions.



Residential Child Care Institutions (RCCI), a part of NSLP, provide nutritious meals and after-school care snacks for the youth of Nevada in public and private, non-profit residential group settings.



School Breakfast Program (SBP) provides nutritious breakfasts for students enrolled in public and private non-profit schools.

Special Milk Program (SMP) provides milk to children in schools and private, non-profit, childcare institutions who do not participate in other Federal meal service programs.



Participants in USDA funded child nutrition programs receive free or reduced price meals based on family household income eligibility. Schools can apply for Provision II status and provide all meals for free in schools with a high free/reduced price enrollment. Snack programs provide free or reduced price snacks based on family household income eligibility. Snack programs qualify for area-wide participation in needy areas where all after-school snacks are provided to the students for free.

The Child and Adult Care Food Program (CACFP) has a common goal of bringing nutritious meals and snacks at no charge to children and adults in day care in a variety of facilities. A maximum of 2 meals and 1 snack, or 1 meal and 2 snacks may be reimbursed per participant each day. The CACFP reimbursement for meals served frees other funds to be used to improve the quality of day care, making it more affordable for many low-income families. CACFP models healthy eating and introduces children to a variety of healthy fruits and vegetables, whole grains, and dairy. Exposure to these healthy foods establishes their preferences

for diet and increases their long-term good health. The At-Risk Meals Program provides supports to children participating in an approved after-school CACFP program.

Definition of nutrition (noun):

1. *The process of nourishing or being nourished, especially the process by which a living organism assimilates food and uses it for growth and for replacement of tissues.*
2. *The science or study that deals with food and nourishment, especially in humans.*
3. *A source of nourishment; food.*

Summer Food Service Program (SFSP) provides nutritious meals during school vacations and track breaks to children from areas in which poor economic conditions exist. School Food Authorities are encouraged to participate in summer food programs through the SFSP or NSLP Seamless Summer Option. In addition to school districts, private non-profit organizations are also encouraged to participate in the SFSP as sponsors and/or feeding sites. The Nevada Department of Education, Office of Child Nutrition and School Health, has developed strong partnerships with Food Bank of Northern Nevada, the Culinary Training Academy (Las Vegas), and Three Square (Las Vegas) to sponsor and/or provide meals to summer and year-round SFSP feeding sites for needy children.

The Fresh Fruit and Vegetable Program (FFVP) exposes children to a wide variety of fresh fruits and vegetables in the hope that they will develop healthy eating habits. Elementary schools that have greater than 50% eligible free and reduced lunch students are eligible to apply yearly for this program. Fresh fruits and vegetables are served during the school day in a variety of settings on a daily basis. The United States Department of Agriculture (USDA) encourages schools to offer fresh fruits and vegetables a minimum of twice a week. FFVP grant funds cannot be utilized as part of the National School Breakfast or National School Lunch Program. Schools will receive funding of \$50-75 per student based on total enrollment of schools participating in the program.

Wellness - The State Board of Education, State Board of Career and Technical Education approved the Statewide School Wellness Policy in June 2005, with local districts implementation by July 1, 2006. All 17 school districts have a wellness policy in place.

The Statewide School Wellness Policy addresses the following areas: goals for nutrition education; physical activity; low-fat and low sodium food choices; appropriate portion sizes for elementary, middle, and high school students; foods of minimal nutritional value; exemptions to the policy; designate 15 minutes for breakfast meal consumption, 20 minutes for lunch meal consumption, and 30 minutes of physical activity; conduct recess before lunch in elementary schools; develop student incentives; designate a school wellness coordinator for each district; establish an advisory council; and develop a plan for measuring implementation of the local policy.







NRS 387.105 Appropriation of state money; matching grant for participation in National School Lunch Program.

1. To enable the State Board to provide for the establishment, maintenance, operation and expansion of programs of nutrition, money must be provided by legislative appropriation from the General Fund as a budgeted part of the appropriation for the support of the Department and must be paid out on claims as other claims against the State are paid.

2. In addition to the amounts provided pursuant to subsection 1, money must be provided by legislative appropriation in an amount that satisfies the amount required as a matching grant from this State for participation in the National School Lunch Program, 42 U.S.C. §§ 1751 et seq., which must be designated as the "Nutrition State Match." For those school districts that participate in the National School Lunch Program, the amount appropriated must be a reduction in the total amount of basic support calculated for those school districts pursuant to [NRS 387.1233](#) and must be

distributed in accordance with [NRS 387.124](#). Each school district receiving money that is designated as a "Nutrition State Match" shall verify that the money is used to support the National School Lunch Program in the public schools located within the school district.

Funding is allocated to each district for the required Nutrition State Match based on the percentage of the reimbursement received for the National School Lunch Program.
